2014-2015 CVP Water Supply Update

The Bureau of Reclamation's initial zero allocation for south-of-Delta CVP agricultural water service contractors has not changed and, due to extraordinarily dry conditions, the District expects that the allocation will remain at zero for this contract year.

2014-2015 Supplemental Water Supply Update

The District has received timely Supplemental Water applications for approximately 248,000 acre-feet on 372,000 acres. The District believes that it can acquire approximately 60,000 acre-feet of Supplemental Water, although the efforts to acquire water will continue. The majority of Supplemental Water is being acquired from north-of-Delta and will be pumped between July and September. For water that is acquired, the District estimates that the delivered cost to water users will be in the range of \$800-\$1,100 per acre-foot. Advance payment for the acquisition cost of the water is required at the time of allocation.

The District will allocate 1,000 acre-feet of Supplemental Water to applicants later this month. Further, on July 8 the Finance & Administration Committee will meet to consider the "advance" allocation of up to 9,000 acre-feet, which will depend upon the pumping schedule and the water's availability.

Proposed Amendment to District Rules and Regulations to Prohibit Furrow Irrigation Rejected

At its meeting on June 17, the Finance & Administration Committee rejected a recommendation to seek approval from the Board of Directors to amend the District's Rules and Regulations for the prohibition of furrow irrigation. The Committee took this action after receiving substantial written and oral comments from landowners and water users who attended the meeting.

Water Ordering Procedures

Due to the low water supply, it is important that water users comply with the District's water ordering procedures. The District is required to place orders with the Department of Water Resources on a daily basis. As a result, any water taken by water users without orders causes variances with DWR that then must be addressed by the District. Further, water users who are found running without orders can have their water turned off.

The schedule for placing water orders is as follows: Water orders for Tuesday through Saturday must be placed the prior day between 7:30 and 9:30 a.m., by telephone or fax. Orders placed over the website are accepted until 10:00 a.m., for the following day. Water orders for Sunday and Monday must be placed by Noon the preceding Friday, either by phone, fax or website. Update on Proposed Canal Integration Program

The District continues to seek approval from the Department of Water Resources and State Water Contractors for conveyance of groundwater in the San Luis Canal. Once an agreement is approved, District staff will host a workshop for project participants at the Five Points Shop and Field Office to discuss operational procedures and to answer questions.

Long Term Irrigated Lands Regulatory Program Enrollment

Those landowners who missed the deadline to enroll in the District's third party coalition are encouraged to submit their Notices of Confirmation to the District as soon as possible to avoid being regulated as an individual discharger or being charged a late fee by the Regional Water Quality Control Board.
