2014-2015 Water Supply and Rescheduling

At the end of November, water users had remaining supplies of approximately 185,000 acre-feet. If demands for water and transfers into the District match staff's projections through February, the District will have about 170,000 acre-feet of water in San Luis Reservoir on March 1, 2015. Because San Luis Reservoir is not projected to fill this year, the District expects that there will be unlimited opportunity to reschedule water into the 2015 contract year.

2015-2016 CVP Contract Allocation

The CVP has approximately 3.2 million acre feet of water in key reservoirs; this represents approximately 52% of the 15-year average. Storage in Shasta Reservoir is approximately 1.45 million acre-feet (58% of 15-year average). Federal storage in San Luis Reservoir is approximately 216,000 acre-feet (38% of 15-year average). With the Jones Pumping Plant operating at about 60% capacity, the federal share of San Luis Reservoir is unlikely to fill by February 28, 2015.

Based upon these conditions and certain assumptions concerning hydrology, District staff is projecting the ranges of potential Central Valley Project allocations for the 2015-2016 contract year as follows:

Supplemental Water Update

The District received timely Supplemental Water applications for approximately 247,000 acre-feet (AF) on 368,000 acres. The District made 41,000 AF available for allocation to water users in December, bringing the total Supplemental Water allocated this year to approximately 101,000 AF. This completes the allocation of all Supplemental Water acquired this year, although the District will continue to try to acquire additional water to meet outstanding requests.

The District estimates that the Supplemental Water delivered cost to water users will be in the range of \$800-\$900 per acre-foot. Advance payment for the acquisition cost of the water is required at the time of allocation.

Revised 2014-2015 Water Rates and Charges

The Board of Directors has revised the 2014-2015 Water Rates and Charges, retroactive to March 1, 2014. The Cost of Service water rate has been increased to \$246.92 per acre-foot, with a corresponding increase in the Full Cost rate. The changes to the water rates and charges were necessary due to lower-than-anticipated surface water deliveries during the year, affecting the San Luis & Delta-Mendota Water Authority O&M, District O&M, and Water Delivered Benefit rates.

The new rates will be implemented on the December water billing statements that are mailed early in January and due January 25, 2015. Low Interest Irrigation Equipment Lease Program

The District's' Expanded Irrigation System Improvement Program (EISIP) offers low interest loans to water users for the lease-purchase of irrigation system equipment. EISIP funds up to \$130,000 towards the purchase of irrigation system equipment, the design of irrigation system and purchase of portable aluminum irrigation pipe, micro irrigation, linear move and center pivots. Assessments and Land-Based Charges

The 2014 Repayment Contract Assessments were delinquent after November 20, 2014. They now are subject to a 5% penalty. Land-based charges were due May 25, 2014 for the first installment and September 25, 2014 for the second installment. Unpaid assessments and land-based charges will result in the interruption of water service to the water user until payment is received. Contact Deborah Tuggle at (559) 241-6212 for payoff amounts.

Backflow Prevention

The District reminds all water users that they are to configure their on-farm distribution system and shall install appropriate equipment to prevent water from reverse-flowing into the District's deliveries and distribution system. Water users that are found to be out of compliance will be contacted and asked to reconfigure their system(s) or install appropriate equipment. Failure to comply could result in termination of water service at the affected deliveries.
