Expanded Irrigation System Improvement Program/PWRPA P3 Grant Application

The District's Board of Directors authorized the Expanded Irrigation System Improvement Program (EISIP); a low interest loan program, which provides certain irrigation equipment to District water users on a lease-to-purchase basis. Water users who are currently enrolled in the Groundwater Management Program, Irrigation System Management Program (ISMP), or Temporary Diversion Program may be eligible to receive a cost share from Public Purpose Program (P3) funding, consistent with the District's Board of Directors determination. The availability of funding can go toward the purchase of irrigation equipment for micro-irrigation systems, linear move and center pivot systems, and portable aluminum irrigation equipment. The EISIP P3 lease may be executed for up to \$200,000 and eligible applicants may receive funding for up to \$70,000 or 35%, whichever is less, towards the total lease purchase of the irrigation system equipment. The balance, up to \$130,000, shall be funded under the terms of the EISIP P3 program. The District will purchase the equipment from the lowest responsive bidder. A down payment of 20% of the remaining (non-P3 grant funded) balance is due prior to the installation of the equipment, followed by four annual principal payments plus 3.1 percent interest on the outstanding balance. The lease period will be four years. This program is independent of any previous low interest loan program to purchase irrigation equipment. Water users who participated in other cost share/grant programs are eligible to participate in this new program. Irrigation equipment purchased under this program may only be installed/used on fields that receive water from a pump enrolled in one of the aforementioned programs.

Leases must be secured by 160 acres of non-annexed land and will be recorded with the appropriate county. The application period for irrigation equipment will be continuously open, and all applicants will be added to the priority list in the order received.
