CALL TO ORDER

There were no corrections or additions to the agenda of items.

APPROVAL OF MINUTES

There being no additions or corrections, the minutes of the Regular Board Meeting of March 16, 2021 and April 25, 2022 stood approved as circulated.

BOARD TO CONSIDER: (A) FINDING EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT THE EXECUTION OF A WATER TRANSFER AGREEMENT BETWEEN WESTLANDS WATER DISTRICT DISTRIBUTION DISTRICT NO.2 AND THE CITY OF COALINGA TO BENEFIT A LANDOWNER/WATER USER IN PLEASANT VALLEY WATER DISTRICT, (B) AUTHORIZING EXECUTION OF SAID TRANSFER AGREEMENT, AND (C) AUTHORIZING RELATED ACTIONS

Mr. Freeman stated the purpose of this item was to seek authorization for the General Manager or designee to execute an agreement for a water transfer out of Westlands Water District Distribution District No. 2 (DD#2) for up to 2,000 acre-feet (AF), to the City of Coalinga (Coalinga) for the benefit of Wood Ag Management, Inc (Wood Ag). The water is being made available for transfer from Wood Ag's Mercy Springs Water District contract assignment, which totals 4,198 AF. Wood Ag expects to make full use of all surface water supplies, and not pump groundwater this water contract year.

Under the proposal, the water will be transferred starting in April based on water demands in Coalinga's service area. The United States Bureau of Reclamation (Reclamation) approved these types of transfers between Central Valley Project Contractors under its South of Delta Accelerated Water Transfer and Exchange Program through 2025. This transfer request is unique because Wood Ag acquired the Mercy Springs Water District supply for its own use.

The District will collect all the applicable Reclamation and District water rates/charges from Wood Ag and transportation charges from Coalinga.

The actions proposed herein are exempt from California Environmental Quality Act (CEQA) because it continues ongoing operations of existing facilities within established parameters without substantial modification (Section 15301 of the CEQA Guidelines); and because it can be seen with certainty that there is no possibility that the water transfer may have a significant effect on the environment, the water transfer is not subject to CEQA (Section 15061(b)(3) of the CEQA Guidelines.

Mr. Gutierrez asked for comments from the members of the public however, none were offered.

Director Anderson moved that that Board of Directors (a) Finds exempt from the California Environmental Quality Act the execution of a water transfer agreement between Westlands Water District Distribution District No.2 and the City of Coalinga to benefit a landowner/water User in Pleasant Valley Water District, (b) Authorizes Execution of Said Transfer Agreement, (c) Authorizes related actions. The motion was seconded by Director Coelho.

SUBJECT:

Consider: (a) Finding Exempt from the California Environmental Quality Act the Execution of a Water Transfer Agreement Between Westlands Water District Distribution District No. 2 and the City of Coalinga to Benefit a Landowner/Water User in Pleasant Valley Water District, (b) Authorizing Execution of Said Transfer Agreement, and (c) Authorizing Related Actions

DISCUSSION:

The purpose of this item is to seek authorization for the General Manager or designee to execute an agreement for a water transfer out of Westlands Water District Distribution District No. 2 (DD#2) for up to 2,000 acre-feet (AF) of the Central Valley Project (CVP) allocation, to the City of Coalinga (Coalinga) for the benefit of Wood Ag Management, Inc (Wood Ag). The water is being made available for transfer from Wood Ag's Mercy Springs Water District contract assignment to DD#2, which totals 4,198 AF, at a 100 percent CVP water allocation. Wood Ag expects to make full use of all surface water supplies, and not pump groundwater this water contract year as a result of the proposed water transfer.

Under the proposal, the water will be transferred starting in April based on water demands in Coalinga's service area. The United States Bureau of Reclamation (Reclamation) granted approval for these types of transfers between Central Valley Project Contractors under its South of Delta Accelerated Water Transfer and Exchange Program through 2025. This transfer request is unique because Wood Ag acquired the Mercy Springs Water District supply for its own use.

The District will collect all the applicable Reclamation and District water rates/charges from Wood Ag and transportation charges from Coalinga.

The actions proposed herein are exempt from California Environmental Quality Act (CEQA) because it continues ongoing operations of existing facilities within established parameters without substantial modification (Section 15301 of the CEQA Guidelines); and because it can be seen with certainty that there is no possibility that the water transfer may have a significant effect on the environment, the water transfer is not subject to CEQA (Section 15061(b)(3) of the CEQA Guidelines.

DRAFT WATER TRANSFER AGREEMENT BETWEEN CITY OF COALINGA AND WESTLANDS WATER DISTRICT DISTRIBUTION DISTRICT NO. 2

This Agreement is made this ____ day of April 2024, by and between Westlands Water District Distribution District No. 2 (WWD) and the City of Coalinga (Coalinga).

RECITALS

- A. WWD is a public agency of the State of California and Coalinga is an incorporated city of the State of California, duly formed and operating under the laws of the state, and are empowered to enter into contracts to manage the water supply available to them for the benefit of their constituents.
- B. WWD is a contractor entitled to receive water which it can beneficially use from the Central Valley Project (CVP) administered by the U.S. Department of Interior, Bureau of Reclamation (Bureau) pursuant to WWD's Contract No. 14-06-200-3365-AC-IR5-P. Coalinga is a contractor with the Bureau and is entitled to receive CVP water pursuant to Coalinga's Contract No. 14-06-200-4173A-IR1-P.
 - C. Coalinga anticipates a water supply insufficient to meet its 2024/25 water demands and desires to obtain additional water supplies from other entities which take delivery of water from the San Luis Unit.
 - D. WWD has, pursuant to Water Code Section 383, determined there is water that is temporarily surplus to the needs of WWD and one of its landowners.
 - E. WWD is willing to transfer **up to 2,000 acre-feet (AF)** of 2024 CVP water to Coalinga, during the remainder of the Contract Year (CY), for the exclusive use: (1) by a landowner that is common to both WWD and Coalinga (Common Landowner), and (2) on lands that are owned by said Common Landowner and eligible to receive CVP water within Coalinga's service area.
 - F. The transfer under this agreement is consistent with authority granted to WWD under Water Code Sections 382 and 35425.
 - G. Coalinga and WWD have determined that the transfer under this Agreement will have no significant environmental impact, will remove no additional water from the Delta and shall

not increase the cost, nor reduce the supply of water to other CVP contractors.

AGREEMENT

 This Agreement shall terminate on February 28, 2025, unless terminated earlier by WWD.

DELIVERY AND COST OF CVP WATER TO COALINGA

- 2. For the sole and exclusive use by the Common Landowner during the 2024/25 CY and on lands that are owned by the Common Landowner and eligible to receive CVP water within Coalinga's service area, WWD will deliver to Coalinga, up to 2,000 AF of CVP water, prior to February 28, 2025 and pursuant to the terms and conditions of the Bureau's approval, including the schedule developed by WWD and Coalinga (see forecast delivery schedule Exhibit A).
- 3. The amount of water transferred to Coalinga will be within the sole discretion of WWD and will be subject to the Common Landowner causing an equal amount of water to be made available from their water user account for transfer to Coalinga.
- WWD shall deliver the water to Coalinga at points on the Coalinga Canal, as provided by the separate conveyance agreement between WWD and Coalinga, dated July 2017.
- 5. Deliveries of water from WWD to Coalinga shall be measured by WWD.
- WWD agrees to pay the United States Bureau of Reclamation contract rate, Restoration Fund, Trinity PUD Assessment Charge, and additional rates for CVP services required to effectuate the transfer.
- 7. Coalinga is responsible for paying the San Luis & Delta-Mendota Water Authority O&M charge, and Westlands Water District transportation charges.
- 8. The payment of charges required by Section 7 immediately above are in addition to the rates and charges the Common Landowners will be obligated to pay pursuant the Westlands Water District's Rules and Regulations and Terms and Conditions of Water Service.
- 9. WWD may terminate this Agreement upon 14 days of advanced written notice to Coalinga.

APPROVALS

10. The performance by both parties to this Agreement is contingent upon and subject to approval of the Bureau and the terms and conditions thereof.

MISCELLANEOUS

- 11. WWD and Coalinga shall cooperate in securing Bureau approvals.
- 12. Coalinga agrees to abide by all provisions of Reclamation Law.
- 13. Any notice, request, tender, demand, delivery, approval or other communication providing for, required, or arising under this Agreement shall be in writing and shall be deemed delivered three business days after deposit in the United States mail, addressed to the party as follows:

- 14. Amendments to this Agreement shall be effective only if in writing, and then only when signed by the authorized representatives of WWD and Coalinga.
- 15. Consistent with the provisions of Water Code Sections 475 and 1244, WWD and Coalinga agree that neither this transfer nor this Agreement is evidence of the availability of surplus water beyond the terms of this Agreement or lack of beneficial use of the water involved in this Agreement, and neither shall contend otherwise.

Dear Mr. Gutierrez:

This letter is a formal request for approval to transfer water during the 2024/25 year from Westlands Water District Distribution District No. 2 to the City of Coalinga. More specifically, the request is for approval to transfer, as needed, up to 2000 acre feet of the water imported from the Mercy Springs Water District to Distribution District No. 2. The exact amount we could transfer will, of course, depend on the actual CVP allocation available for this year. This is not a request to transfer "regular" Westlands allocation supplies.

The Mercy Springs water allocation for Distribution District No. 2 is available solely to the land within Distribution District No. 2, all of which is owned by David E. Wood, who imported the water. This particular water is not available for use by any other Westlands landowner, and thus transferring it will not affect any other landowners in Westlands. We simply wish to temporarily transfer water we imported into the district.

Thankfully, given the abundance of precipitation recently, we will not have to rely on any ground water pumping for the current water year, and also plan to use a portion of the water supplies to further re-charge the aquifer and develop additional ground water credits.

Please include this request on the next available agenda for the Water Policy Committee and the Westlands Board of Directors.
